- ≥2009--With merger, large staff turnover
- ➤ 2008--Began BFHI work in earnest
- ➤ 2012--Entered Discovery Phase
- ➤ 2013--Entered Development Phase
- ≥2014--Entered Dissemination Phase
- ➤ 2015--Entered Designation Phase
- ➤ October 2016--Designated Baby-Friendly Hospital

### Training Requirements for Baby-Friendly

- Maternity Nursing Staff
  - o 20 hours
    - Inclusive of 15 sessions identified by UNICEF/WHO
    - × 5 hours of supervised clinical experience
- Healthcare Providers with privileges for labor, delivery, maternity, and nursery/newborn care
  - o 3 hours of education pertinent to their job role
- Others (not limited to):
  - Pharmacist importance of exclusive breastfeeding, medications acceptable for breastfeeding
  - Social worker, discharge planner importance of exclusive breastfeeding, community resources that support breastfeeding
  - Anesthesiologist importance of exclusive breastfeeding, importance of immediate skin-to-skin contact
  - Radiology importance of exclusive breastfeeding, where to find out about safe medications for use during lactation, where to find appropriate information on use of radioisotopes during lactation

### How do you want to deliver the information?

#### **Develop Own Course**

#### Pros

- Better retention of material
- Can incorporate hands on training
- Specific to the patient population

#### Cons

- A LOT of work
- Needs a very dedicated staff to pull this off
- Expense


#### Pros

#### Week before...

- Email/Invite to class
- Printouts of education materials
- Printout of CME certificates/sign-in sheets/evaluations
- Make signup calendar for clinical competency check offs
- Order food

#### Day before...


- Room preparation
- Audio and video set up

#### Day of...

- Be early so things can start on time(ish)
- After...
  - Turning in evaluations/sign-in sheets
  - Logging training

- 4 hours scheduled with IBCLC




### Other

### OCH Regional Medical Center

Newborn Deliveries 947 / year October 1, 2015 - September 30, 2016

- OCH Regional Medical Center (OCH) is a licensed 96-bed acute care health facility located on a 20-acre site in Starkville, Mississippi.
- In 1973 the Hospital was constructed at its present site and was named Oktibbeha County Hospital.
- In 2007 the Board of Trustees, through the Hospital's Long Term Strategic Plan, approved a more comprehensive and integrated approach to marketing the Hospital to the Golden Triangle Community, and with focus surveys with community members, it was felt the name did not convey the geographic area serviced by the Hospital.
- In February 2010 the Board of Trustees recommended to the Oktibbeha County Board of Supervisors that the legal name not be changed but that the Hospital operates using "Doing Business As" d/b/a OCH Regional Medical Center.

### OCH Regional Medical Center

#### POPULATION OF OCH REGIONAL MEDICAL SERVICE AREA

- A total of 177,387 people live in the 3,515.24 square mile report area according to the U.S. Census Bureau American Community Survey 2010-14 5-year estimates. The population density for this area, estimated at 50.46 persons per square mile, is less than the national average population density of 88.93 persons per square mile. OCH's service area is comprised of 51.62% who identify as female and 48.38% who identify as male.
- Median age in Oktibbeha County was 25.3 years, Choctaw County was 42.8 years, Clay County 39 years, Lowndes County 36 years, Noxubee County 36.6 years, Webster County 41.1 years, and Winston County 40.3 years.
- The service area can be further defined by race as 53.76% white, 43.93% black, 1.13% Asian, 0.13% Native American/Alaskan, 0.39% some other race, and 0.66% multiple races. Additionally, 1.42% of the service area was Hispanic.

Having Hospital and Nursing Administration support to move forward.

Nursing Stakeholder Team Meetings and Unit Meeting discussions.

#### What would we have done differently?

RAPP Training and Charting Implementation started along with Skin to Skin Initiation.

Start date for implementation of rooming in for all patients more clearly defined.
